Holland Patent Esports Constitution

1. Name and Purpose

- a. The name of this organization is Holland Patent Esports.
- b. This team is an extracurricular activity and that the experience of participation in esports contests and activities should reflect the total educational goals of our district. To allow for the development of physical growth, mental alertness, and emotional stability for all those who participate in athletics.
- c. The purpose of this club is to raise monies to support the high school esports team dinners, banquets, clinics, camps, workshops, tournaments, supplies, equipment and essential items which are not covered in the regular school budget. The monies raised will be used solely to support the activities and needs of all the members of the team.

2. Eligibility for Membership

a. Candidates are given tryouts for a minimum of three (3) days. Candidates must be full time student at Holland Patent High School to be eligible for membership.

3. Selection of Members

- a. All candidates are selected based on criteria developed by the staff as well as a skill rubric from which all players are evaluated. Students will be told of what the rubric will be assessing prior to the tryout.
- b. Final selection of the team is done by the club officers and advisor.
- c. Players will be notified of their selection to the team.

4. Dismissal of Members

- a. Players who fail to follow either the Code of Conduct for Interscholastic Sports or team rules as established by the advisor and team officers will be dismissed from the team upon conferring with the player, advisor, parent and high school administrator.
- b. Neglect of duty of non participation in team events will warrant a member being dismissed by a ¾ vote of the team. Any member who misses three meetings without a legitimate excuse will be put on probation for the rest of the season. Any member who is on probation and misses a fourth meeting without a legitimate excuse will be removed from the team for the remainder of the school year. If said member is an officer, he other officers will move up and elections for a new representative will take place.

5. Officers/Captains

- The officers of this organization shall be chosen by either the advisor and/or the team.
- b. The president shall preside at all meetings, call special meetings when necessary, vote in case of a tie and assume such other duties as are generally associated with this office. The VP shall act as president pro-tempore, appoint all committees serve as overall chairman of the standing committees, and perform other duties that are generally associated with this office. The Recording secretary shall keep an accurate record of all meetings. These records shall be catalogued and filed for a minimum of five years. The treasurer shall keep a record of expenditures and receipts and be prepared to make a report of the finances at any meeting at the request of the

president, or any other memberl. Representatives have all the privileges associated with regular membership including the right to vote.

6. Supervision

- a. Activities of this group shall be subject to the approval of the high school principal and advisor.
- b. Monies raised by this club shall be deposited in the high school extra curricular account.

7. Fundraising Procedures

- a. Funds will be raised only after a majority vote of team members and in accordance with building and district procedures.
- b. Fund collection will be supervised by the team officers and advisor.
- c. Fund expenditures must be pre-authorized by the team and supervised by the advisor.
