As we navigate through these extremely challenging and unprecedented times, I want to assure you the entire Holland Patent Central District Team is working together to implement plans to support our students and community. The information included below is to clarify some questions our families may have and also update you on plans we have in place to address the school closure:

- All schools/ buildings are closed to the public and scheduled to reopen on Tuesday, April 14, 2020. Therefore, all District events, and building usage events are postponed indefinitely and may be rescheduled at a later date. The spring sports season is scheduled to begin on April 14. - Student work will be delivered by bus by Wednesday, March 18, 2020. Elementary student belongings are being packaged and sent home with work and <u>left at the front door</u>. Middle and High school students can email their building principals to gather their belongings and will be sent home with work and <u>left at the front door</u>.
- School nurses will be reaching out to families by Monday afternoon to make arrangements to pick up needed student medications by Tuesday, March 17.
- Beginning on Tuesday, March 17, we will be providing grab and go meals (bagged lunch and breakfast) at our High School loading dock (behind the cafeteria) location between the hours of 10:00 am- 12:00pm. If you cannot pick up, please call (315) 865-7242 or email Cliff Casab, Manager of Food Service, at ccasab@hpschools.org to have food delivered and left at your front door.

This is a fluid situation and new information is coming at us at a tremendous rate. We will keep you updated as to any changes to our protocols as we adjust accordingly.
