SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The Holland Patent Central School District developed a plan based on feedback and recommendations from staff, district leadership, Board of Education and the general public. The general public was provided an opportunity to make recommendations at a Community Forum on August 23, 2021. An additional meeting will be held on December 15, 2021 targeting stakeholders who represent the interests of students with disabilities, English Language Learners, students who are struggling emotionally, as well as students who are struggling academically. An agenda and information regarding the use of funds was distributed which included summer programs targeted on intense tutoring in ELA and Math, as well as camps targeted at science, social studies and physical activities. Feedback was verbally given to the district from the attendees which was considered if it was an allowable expense as determined by New York State Education Department. In the future, the Holland Patent Central School District will keep the community abreast of learning opportunities via Board of Education meetings, district forums, district newsletters, school newsletters and other communications as appropriate. The district will encourage feedback from all stakeholders in these meetings and community. A committee made up of community members, HPTA members, CSEA members, and HPAA members reviewed multiple factors, including COVID related concerns as well as meeting with the Oneida County Department of Health. The implementation of the plan will be coordinated with the administration, teachers and board members with input being received via Parent Square as well as being reviewed at each BOE meeting. There is the ability for recommendations of change through the stakeholder review both in person meetings and committee level meetings of staff and administration.

The Holland Patent Central School District will be analyzing the following to ensure we are utilizing multiple measures of data:

- STAR ELA and Math Assessments these assessments are given 3 times a year to progress monitor student growth. The data is used to determine what interventions students need to ensure academic growth.
- Grade level/course benchmark assessments these assessments are given quarterly to determine areas that need to be addressed regarding learning
 loss due to the pandemic. The data is analyzed by our School Based Intervention Teams (SBIT) to determine assistance students need in the
 classroom.
- Attendance trends the HPCSD analyzes attendance of students in order to be able to address the type of assistance the students need. We are offering a 3-5 tutoring program so students can get extra help when missing school. Teachers are available every night in every subject.
- Social Emotional Learning referrals social workers and guidance counselors work with teachers and principals to address student SEL issues. We
 have Connected Community Schools in every school to assist the school in addressing these issues.
- Behavioral disciplinary referral discipline issues have risen since the pandemic hit our social workers and guidance counselors analyze our data to assist student in dealing with the Social Emotional isssues. We use community agencies when warranted.
- ESSA Subgroup data we analyze our subgroup data (Economically Disadvantaged, SWD, etc.) during SBIT so we can determine what assistance is need to help our students.
- COVID Quarantine data per building data is analyzed on a weekly basis to determine what assistance students need we analyze absences along with classroom performance to identify students.
- Classroom Evaluations building administrators observe classrooms to determine and analyze which students may be falling through the cracks, these students are discussed and plans developed at SBIT meetings.

The Holland Patent Central School District will be utilizing the required reserve 20% funds to address the impact of loss of instruction. The district will focus on the following to ensure learning loss is addressed: Instructional Coaches for ELA and Math, a teacher on special assignment will be coordinating and aggregating data for administration, teacher review of student performance and growth. The district will continue to monitor student progress and collaboratively review and re-calibrate student programming as needed which includes after-school programming, remediation, acceleration, Response to Intervention, differentiation, vocabulary acquisition. Tier one will be a focus as well. After school programming will be after school from 3-5 to assist students with targeted instruction provided by certified teachers to address learning loss and any continued loss of instruction due to quarantines. This will be a continued process with constant review for improvement to help all students in need of additional support.

The remaining funds will be utilized to provide supports to our instructional staff with professional learning on continued implementation of Reading in the Content Area, as well as best practices and instructional strategies in the classrooms. We will be contracting with the Tovani group - site visits will be conducted where the Tovani group will be observing teachers and then conduct lab days where Cris Tovani and Sam Bennett will be modeling for our teachers how to engage all students in the classroom as well as teaching them how to teach reading in the individual content areas. Best practices will be modeled for our teachers with the purpose of increasing the amount of time students read as well as how to engage every student in the classroom. Instructional coaches will be working with teachers in the classroom to improve instruction to address student deficits. In addition, class sizes have been reduced so the teacher to student ratio is below 18-20 students per section. Additional technology will be purchased in order to support our grade level/content teachers integrating technology in the classroom. Monies will also be dedicated to after school and summer programming in order to address Social Emotional needs as well as academic needs. The Registered Nurse will be used to assist with paperwork, as a result of the COVID 19 pandemic, in each of our 4 buildings which will allow our nurses to attend to children that have other health issues. The COVID Coordinator will work with Oneida County Health Department as well as the New York State Department of Health developing Test to Stay protocols, developing permission slips, assisting principals with contact tracing and keeping abreast of the daily changes coming from the CDC. The Library Media Specialist will assist all students with reading instruction in order to enhance the growth of ELA skills to address learning loss they have experienced these past 2 years as a result of the pandemic.

7. With the implementation of our Instructional Coaches and Reading in the Content Area Framework, we will be collaboratively reviewing our district, individual school, grade level, course, and individual/group data to revise programming and offerings as needed to best support our students and increase achievement. The data will assist us in determining what student support is needed as a result of the COVID-19 pandemic which will focus on students with disabilities, ELLs, low-income students and our students in foster care. The SEL teachers will be focusing on these students in the following subgroups which are identified using ESSA data. Programs will focus on additional interventions needed in small groups and individual settings where students will have additional access to certified teachers, social workers, counselors, related services and outside agencies. In addition, mixed groups of these students will be set up by the SEL teacher to address any deficits they have focusing on mental health needs. The data will be continuously analyzed so that we can make informed decisions in the best interest of children. We will implement the Positivity Project to train our students in need with coping skills as we move forward in addressing their Social Emotional Learning.
