Daily Expectations

- Required services such as OT, PT, Speech and Resource Room must be attended. If there are issues, please contact your child's teacher and/or principal immediately.
- District Level meetings will be set up for parents and students who are not responding to phone calls or emails regarding maintaining communication with teachers/principals, completing assignments and other assessments.
