15-327 **DISTRICT UPDATE**

The board continued their discussion on class sizes. Dr. Davis had provided date in their packets and read the recommendation of the committee that met on the topic. Following a break discussion the board made a decision.

15-330 **FIRE INSPECTION UPDATE**

Mr. Geer reported that the fire inspection went well. A few minor adjustments were made. It was noted that Principal DeAngelo's building was at 100% and Principal Casab's building was very close behind. The inspectors were pleased at our compliance.

15-331 SCHOOL REPORT CARD

Dr. Davis had provided the board with a copy of the School Report Card. Based on some of the date, the district will continue to strategize in the area of individual instruction to reach every child.

Dr. Davis provided some data on costs associated with teacher absences and substitute teachers. There is a regional shortage of substitute. The board requested additional information and will be discussed at a future meeting.

Dr. Davis provided the information requested by the board at the last meeting. The Homework Policy was discussed. Mrs. Berez-Kelly requested that Pre-K be included in the listing, since the policy did not include Pre-K. The board agreed, with the exception of Mr. Allen, that it is a guideline and it is the teacher's responsibility to determine appropriate homework assignments. Complaints with regard to homework has been nil to minimum.

Dr. Davis reported that our tax collector is unable to continue in her regular hours. Dr. Venettozzi has reached out to Adirondack Bank to discuss the collection of taxes by the bank. It would be more secure to have monies go directly to the bank rather than held at the district. Mrs. McGahey reported that Mrs. Zacek would like to still be involved with the process. Dr. Davis suggested that Mrs. Zacek be retained since the district will still need a collector for the preparation of the collection season and for follow-up reporting after the collection process. Dr. Davis will reach out to Mrs. Zacek.
