- Budget for 2022-2023 has not been approved since there was not a quorum in May. The 2022-23 Proposed Budget consists of the following:
 - Professional Salaries - \$ 28,500
 - Director's salary be restored to what it was before - \$20,000
 - Mentor Leaders - \$4,000
 - Micro Credential Coordinator - \$1,500
 - Workshop Presenters - \$3,000
 - Support Staff Salaries - \$3,000
 - Patty Cristman who manages flyers, website, and all certificates
 - Purchased Services - \$500
 - Contract with Alyssa Mittiga to continue support reading strategies for struggling readers
 - Supplies and Materials - \$7,006
 - Books to complete books studies; 5 Break Out EDU licenses, ASCD membership and poster printer supplies
 - Travel Expenses - \$463
 - Covers the travel expenses and registration fee for required state conferences
 - Employee Benefits - \$2,410
 - Based on district contract rate
