4. Director's Report

Discussion on Mentoring Program – Proposal made to make the Mentoring program more effective by having “Experts” in each building to meet needs based on grade level and building. Elementary will be Pam D’Elisa and HS Lisa Sztot. Mentoring program and training will still be overseen by Ericka. Pam and Lisa will be the “go to” for their levels and provide individualize PD. Mentors will be trained first by BOCES, then in house. We are in need of HS mentors. Will mentor full year Long Term subs.

2020-21 Budget - Roughly \$3000 left in Professional Salaries – some will go to Ericka, Lisa and Pam to update Mentoring
- Other ideas include a PLC for choosing a Math Program that aligns with Next Gen standards and is user friendly
- Put out feelers for other ideas – would like to support PLCs that will help teachers adjust their curriculum in order to address the effects of the pandemic

2021-2022 Continuation Application – Funds will be the same as last year which is disappointing considering how much Teacher Centers have been utilized and the amount of stimulus funding.
