RESOLUTION REPLENISHING/RE-ESTABLISHING TAX CERTIORARI RESERVE FUND

WHEREAS, the Board of Education of the Holland Patent Central School District has previously authorized the establishment of a Tax Certiorari Reserve Fund pursuant to Education Law Section 3651 for the payment and claims arising out of tax certiorari proceedings and tax refunds.

WHEREAS, said Tax Certiorari Reserve Fund is in need of replenishment for the purpose authorized by the Board of Education prior to depletion of said funds previously authorized balance,

NOW, THEREFORE, the Board of Education hereby authorizes the transfer of \$600,000.00 from the general fund balance of the Holland Patent Central School District and thereby authorizes the re-establishment of the fund for a total of \$973,309.86 for the purpose of covering outstanding liabilities for continued payment for claims arising out of tax certiorari proceedings and tax refunds effective June 30, 2010.

RESOLUTION ESTABLISHING RETIREMENT CONTRIBUTION RESERVE FUND

BE IT RESOLVED, by the Board of Education of the Holland Patent Central School District, pursuant to Section 6-4 of the General Municipal Law, as follows:

- 1. The Board hereby establishes a reserve fund to be known as the Retirement Contribution Reserve Fund.
- 2. The source of funds for such fund shall be such amounts as may be provided by budgetary appropriation or taxes raised for the reserve, revenues that are not required by law to be paid into any other fund or account, amounts from a repair reserve fund established pursuant to 6-d of the General Municipal Law (supported by the same tax base) or a reserve fund established pursuant to Section 3651 of the education Law subject to a resolution and a public hearing held on at least fifteen (15) days prior published notice, and such other funds as may be legally appropriated.
- 3. Except as otherwise provided by law, the Board of Education, by resolution, shall only authorize expenditures from such fund for:
 - a. the payment of "retirement contributions", which are defined as all or any portion of the amount payable to the New York State and Local Employees' Retirement System, pursuant to Sections 17 or 317 of the Retirement and Social Security Law; or
 - b. The transfer of a portion of the moneys in such fund to a repair reserve fund established pursuant to 6-d of the General Municipal Law (supported by the same tax base) or a reserve fund established pursuant to Section 3651 of the education Law subject to a public hearing held on at least fifteen (15) days prior published notice.
- 4. The Treasurer is hereby authorized and directed to deposit and invest the monies or such fund in accordance with Section 10 and 11 of the General Municipal Law and other applicable law and as provided by Section 6-r of the General Municipal Law. Any interest earned or capital gains realized on the money so deposited or so invested shall accrue to and become a part of each such fund.
- 5. The Treasurer shall account for this fund separate and apart from all other funds. Such account shall show: (a) the source, date and amount of each sum paid into the fund; (b) the interest earned by such fund; (c) the capital gains or losses resulting from the sale of investments of the fund; (d) the

order, purpose thereof, date and amount of each payment from this fund; (e) the assets of the fund, indicating cash balance and a schedule of investments. The Treasurer, within sixty (60) days of the end of each fiscal year, shall furnish a detailed report of the operation and condition of this fund to the Board of Education.

- 6. The sum of \$500,000 is hereby appropriated to such fund, to be paid from the general fund balance.
- 7. This Resolution shall take effect immediately.

RESOLUTION ESTABLISHING INSURANCE RESERVE FUND

BE IT RESOLVED, by the Board of Education of the Holland Patent Central School District, pursuant to Section 6-n of the General Municipal Law, as follows:

- 1. The Board hereby establishes a reserve fund to be known as the Insurance Reserve Fund.
- 2. The source of funds for such fund shall be such amounts as may be provided therefor by budgetary appropriation, amounts from any other fund authorized by the General Municipal Law subject to permissive referendum or such other funds as may be legally appropriated.
- 3. The amount paid into such fund during any fiscal year shall not exceed the greater of Thirty Three Thousand Dollars (\$33,000.00) or five per centum (5%) of the total budget fur such fiscal year.
- 4. Monies in such fund may be appropriated only to fund certain uninsured losses, claims, actions or judgments for which the District is authorized or required to purchase or maintain insurance. Monies in such fund may also be appropriated for expert or professional services in connection with the investigation, adjustment, or settlement of claims, actions or judgments.
- 5. The Treasurer is hereby authorized and directed to deposit and invest the monies of such fund in accordance with Sections 10 and 11 of the General Municipal Law and other applicable law and as provided by Section 6-n of the General Municipal Law. Any interest earned or capital gains realized on the money so deposited or so invested shall accrue to and become a part of each such fund. The Treasurer shall account for this fund separate and apart from all other funds. Such account shall show: (a) the source, date and amount of each sum paid into the fund; (b) the interest earned by such fund; (c) the capital gains or losses resulting from the sale of investments of the fund; (d) the order, purpose thereof, date and amount of each payment from this fund; (e) the assets of the fund, indicating cash balance and a schedule of investments. The Treasurer shall also keep a separate account for each kind of risk funded.
- 6. The sum of \$100,000 is hereby appropriated to such fund, to be paid from the general fund.

7. This resolution shall take effect immediately.

APPENDIX A SCOPE OF WORK

The QUESTAR III will provide the QUESTAR III internal auditor who shall perform the following WORK for DISTRICT on a per diem basis:

A. <u>Internal Audit Services</u>

QUESTAR III will use sampling techniques to test significant operational controls to determine if DISTRICT's internal control structure is operating as designed. This service follows, and is based upon, DISTRICT's risk assessment undertaken no more than one year before the audit service.

Deliverables: Report to DISTRICT the strengths and/or weaknesses of its internal controls and make recommendations to remediate deficiencies. The internal auditor will also provide an annual update to the financial risk assessment.

B. Financial Risk Assessments Update

QUESTAR III will review the previously issued financial risk assessment and update the report to reflect the District's progress on correcting previously identified risks. The updated assessment will also consider the current status of the operation and may include risks not previously identified. This service shall include the following:

- Discuss financial controls, operations and procedures with management and key staff members;
- Review past financial risk assessment comments;
- Update previously prepared risk assessment to reflect changes in the control environment;
- Assessment of the current operating environment for the purpose of determining if financial risks have changed and require reporting in the update assessment.

Deliverables: Report to DISTRICT results of financial risk assessment, to include recommendations for process improvements, if any.

APPENDIX B

SCHEDULE OF FEES

A. DISTRICT agrees to pay QUESTAR III the following fees for WORK identified in Appendix A of this AGREEMENT:

All inclusive cost to perform this service is \$12,130.

This fee includes a maximum of one area of internal audit service as well as one updated risk assessment. This fee was developed based on our understanding of the size and complexity of the district. The fee could be higher or lower depending on the quality and availability of the information requested at the commencement of the engagement.

B. QUESTAR III will provide DISTRICT with ten monthly invoices for services. DISTRICT will pay QUESTAR III no later than thirty (30) days from the date of the billing statement.

Adopt the following resolution regarding the Bus Bond:

BOND RESOLUTION DATED JUNE 16, 2010 OF THE BOARD OF EDUCATION OF THE HOLLAND PATENT CENTRAL SCHOOL DISTRICT AUTHORIZING NOT TO EXCEED \$305,754 AGGREGATE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS TO FINANCE THE ACQUISITION OF SCHOOL BUSES, AT AN ESTIMATED MAXIMUM AGGREGATE COST OF \$305,754, AUTHORIZING BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE LEVY OF TAXES IN ANNUAL INSTALLMENTS IN PAYMENT THEREOF, THE EXPENDITURE OF SUCH SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the qualified voters of the Holland Patent Central School District, New York, at the annual meeting of such voters duly held on May 18, 2010, duly approved a proposition authorizing the levy of taxes to be collected in installments, in the manner provided by the Education Law, for the specific objects or purposes hereinafter described; now therefore

BE IT RESOLVED BY THIS BOARD OF EDUCATION AS FOLLOWS:

<u>Section 1</u>. The Holland Patent Central School District has undertaken or shall undertake certain capital expenditures, as more particularly described in Section 3 hereof.

<u>Section 2</u>. The Holland Patent Central School District is hereby authorized to issue its General Obligation Serial Bonds in the aggregate principal amount of not to exceed \$305,754, pursuant to the Local Finance Law of New York, in order to finance the specific objects or purposes described herein.

<u>Section 3</u>. The specific objects or purposes to be financed pursuant to this resolution (hereinafter referred to as "purpose") are the acquisition of two new/unused 65 passenger school buses with 2 way radio and digital camera and two new/unused passenger conversion vans with 2 way radio and digital camera,

<u>Section 4</u>. It is hereby determined and declared that (a) the maximum aggregate cost of said purpose, as estimated by the Board of Education, is \$305,754, and such amount is hereby appropriated therefor, (b) the Holland Patent Central School District plans to finance the cost of said purpose entirely from funds raised by the issuance of said Bonds and the Bond Anticipation Notes hereinafter referred to, and (c) no money has heretofore been authorized to be applied to the payment of the cost of said purpose.

<u>Section 5</u>. It is hereby determined that the purpose is one of the class of objects or purposes described in Subdivision 29 of Paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is five (5) years.

<u>Section 6</u>. The Holland Patent Central School District is hereby authorized to issue its Bond Anticipation Notes in the aggregate principal amount of not to exceed \$305,754, and is hereby authorized to issue renewals thereof, pursuant to the Local Finance Law of New York in order to finance the purpose in anticipation of the issuance of the above described Bonds.

<u>Section 7</u>. It is hereby determined and declared that (a) there are presently no outstanding Bond Anticipation Notes issued in anticipating of the sale of said Bonds, (b) the Bond Anticipation Notes authorized hereby are not issued in anticipation for Bonds for an assessable improvement.

Section 8. It is hereby determined and declared that the Holland Patent Central School District reasonably expects to reimburse the general fund, or such other fund utilized, not to exceed the maximum amount authorized herein, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of issuance of such obligations. This is a declaration of official intent under Treasury Regulation \$1.150-2.

<u>Section 9</u>. The faith and credit of the Holland Patent Central School District, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such Bonds and Bond Anticipation Notes as the same respectively become due and payable. And annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be levied on all taxable real property of said School District, a tax sufficient to pay the principal of and interest on such obligations as the same become due and payable.

<u>Section 10</u>. The power to further authorize the issuance of said Bonds and Bond Anticipation Notes and to prescribe the terms, form and contents of said Bonds and Bond Anticipation Notes, subject to the provisions of this resolution and the Local Finance Law of New York, including without limitation, the consolidation with other issues, the determination to issue Bonds with substantially level or declining annual debt service, and to sell and deliver said Bonds and Bond Anticipating Notes, is hereby delegated to the President of the Board of Education or to the Vice President of the Board in the event of the absence or unavailability of the President. The President of the Board of Education and the District Clerk are hereby authorized to sign by manual or facsimile signature any Bonds and Bond Anticipation Notes issued pursuant to this resolution, and are hereby authorized to affix to such Bonds and Bond Anticipation Notes the corporate seal of the School District and to attest the same.

<u>Section 11</u>. This resolution, or a summary hereof, shall be published in full by the District Clerk of the School District together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the School District. The validity of said Bonds and Bond Anticipation Notes may be contested only if such obligations are authorized for an object or purpose for which said School District is not authorized to expend money, or the provisions of law which should be complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

<u>Section 12</u>. This resolution shall take effect immediately upon its adoption.

Approve the Memorandum of Agreement for the four day work week for the CSEA and HPAA.

Approve the extension of the contract agreement by and between the Holland Patent Central School Superintendent of Schools and the Holland Patent Teachers Association to become effective July 1, 2010 to June 30, 2014.

Approve the request of Ericka Gerace for a leave of absence for the revised period of May 21, 2010 through to June 30, 2010.

Approve the request of Heather Roberts for a leave of absence for June 24, 2010.

Approve the following tenure recommendations:
